

High-level Interactive Seminar

Key Achievements of the G20 Indonesian Presidency (2022):

The Case of Energy Transition and Climate

Date and Venue:

The seminar will take place at the sidelines of IsDBG's 48th Annual Meetings which will be held in Jeddah, Saudi Arabia, on 10-13 May 2023 under the theme "Partnerships to Fend Off Crises". The seminar will be held physically on Friday 12 May 2023, 02:00PM-04:00PM, at the "Al-Ezz 1" Auditorium of the Ritz Carlton Hotel, Jeddah.

1) Background, Context, and Rationale:

The Republic of Indonesia assumed the presidency of the G20 throughout 2022, adopted an ambitious agenda under the theme "Recover Together, Recover Stronger", which focused on three main primary topics: Global Health; Digital Transformation; and Energy Transition. Despite the global geopolitical and economic crisis, the Indonesian G20 presidency managed to achieve remarkable success on all topics addressed. A case in point was the successful launching the Energy Transition Mechanism "ETM" Country Platform. The platform aimed to act as a key coordination and delivery vehicle to drive forward Indonesia's just and affordable energy transition. The initiative also aimed to consolidate Indonesia's position as a global leader in the field of clean and renewable energy. The initiative was evidence to the success of the Indonesian G20 Presidency and provides a solid example on the power of global partnerships such as the G20 in fending off global crises in crucial areas such as Energy transition.

This interactive seminar aims to serve as a platform to shed light on the success of the G20 under the Presidency of Indonesia in advancing global energy transition efforts. Towards this, the event will focus on the Launching of the "ETM" Country Platform as an innovative initiative to form global partnerships to support energy transition and enforce climate action, in line with the main outcomes and recommendations of the COP27. In this context, the event will also highlight the efforts of the Saudi government, the achievements of Egypt's CoP27, and the preparations for UAE's CoP28 with respect to promoting energy transition and climate action.

Finally, te event will also provide an opportunity to officially launch the <u>"IsDBG's</u> <u>Participation in G20 2022 under Indonesia's Presidency" report</u> which was prepared by



IsDB G20 Sherpa team to take stock of IsDBG's multiple engagements in the G20 2022 to support Indonesia.

2) Issues to be Addressed:

The side event aims to shed light on the key achievements of 2022 Indonesian G20 presidency, with a particular focus on energy transition and climate. The event will also highlight the related efforts of the Saudi government, the achievements of Egypt's CoP27, and the preparations for UAE's CoP28. - 3. Shedding light on the key achievements of the Indonesian G20 presidency in 2022 in addressing global crisis in crucial areas such as Energy transition and climate.
- 4. Showcasing the Energy Transition Mechanism "ETM" Country Platform launched in November 2022 by the Indonesian G20 presidency, as an innovative initiative to reinforce global partnerships for energy transition and climate action, in line with the main recommendations and outcomes of the COP27.
- 5. Highlighting the efforts of the Saudi government, the achievements of Egypt's CoP27, and the preparations for UAE's CoP28 in promoting energy transition and climate action
- 6. Exploring the most important insights and lessons learned by Indonesia, KSA, Egypt, and UAE and IsDB, related to the power of global partnerships to fend off crises in areas of energy tranition and climate.
